# **Canvas Health**

Written Consent for Referrals and Sharing Substance Use Program Treatment Records with other Canvas Health Programs

Canvas Health is a Certified Community Behavioral Health Clinic (CCBHC). We combine and coordinate across mental health, behavioral health and substance use disorder care. If your Canvas Health Substance Use Program provider thinks you might need help from someone else at Canvas Health, they'll talk to them and share access to your substance use records, but only if you agree to it.

We can provide better care for you when every Canvas Health provider who helps you can access your entire health record, including any of your records from our Canvas Health Substance Use Program. If you don't want help from another Canvas Health program, or you do not consent to the sharing of access to your records, your records would not be shared outside the Canvas Health Substance Use Program. Canvas Health will not share your information outside of Canvas Health, unless you provide written consent or we are required to do so by law.

"Canvas Health Mental Health" is a general designation that is used to refer to any or all of the following programs and their providers, who practice at various Canvas Health offices, satellite offices, or in community-based settings: ARMHS, Adult Case Management; Childrens Case Management; Targeted Case Management, Care Coordination; Children's Therapeutic & Support Services – Skills Training (CTSS); Crisis Services; Day Treatment & Intensive Support Groups, Early Childhood Clinical Services, Early Childhood Consultation; Functional Family Therapy; Family Treatment Program; Outpatient Therapy; Psychological Evaluation & Treatment; Psychiatry; School-Based Mental Health Services; Therapeutic Learning Center (TLC) & Therapeutic Education Collective (TEC).

"Canvas Health" is a general designation that is used to refer to "Canvas Health Substance Use Program", "Canvas Health Mental Health", and any administrative staff that support the functions of both "Canvas Health Substance Use Program" or a "Canvas Health Mental Health."
