

As the pandemic continued in 2021, Canvas Health's staff, clients, and supporters again displayed their tenacity and resiliency as we joined together to build on the agency's legacy of anticipating and responding to community need.

Drawing upon innovative uses of technology, our clinicians and clients connected effectively and creatively, while carefully bringing back in-person care to our clinics and community locations.

We worked diligently throughout the year to complete and submit our Certified Community Behavioral Health Clinic (CCBHC) application. After approval in 2022, we immediately began expanding and adding services, including continued 24/7/365 access to crisis care; adult rehabilitative mental health services; care for military personnel and veterans; care coordination; access to medicationassisted treatment; and other whole person care services.

Other capacity-building initiatives in 2021 included the construction of a new public website, recruitment of new Board of Directors members with diverse experience and backgrounds, work and training on Diversity and Inclusion, as well as implementation of our new Electronic Records System.

As Canvas Health's new CEO, I feel honored to lead the agency through this pivotal time, while keeping excellent clinical care at the forefront of all of our actions and decisions. As always, we are grateful for our community's support. It's because of you that we can continue building on our legacy of providing hope, healing, and recovery to the people we serve.

## **TIME TO INSPIRE** After working toward recovery, Canvas Health client returns to help others

Jim<sup>\*</sup>, a client in our substance use program, has had five DUI charges, is on home monitoring, and could be sentenced to eight years in prison if he doesn't fulfill probation requirements.

Over his lifetime, he's experienced alcohol abuse, self-harm, suicide attempts, and prison time. He has been to treatment multiple times, most recently in one of our Forest Lake substance use groups. After completing group treatment, he continued to see one of our substance use counselors.

Jim recently has been attending Canvas Health's current substance use groups to tell about his experiences with being in recovery. He's grateful for the progress he's made and wants to inspire others to keep up the hard work of healing.

## **HOME RUNS & A WHOLE LOT OF HEART** SOS Softball Tournament hits it out of the park

Alexa was just 15 when she lost her best friend, Alissa, to suicide.

Over the years, Alexa has faced her own personal mental health challenges, and has seen others in her life struggle, too.

A self-proclaimed "fighter", Alexa is passionate about giving back to the people and causes that she loves. "I've always believed that everyone has the power to bring sunshine to another person's life, whether they've been friends for a long time, or they just met," she said.

In 2020, she decided to combine her passion for helping people, love of softball, and her desire to honor Alissa into the Annual SOS Softball Tournament. The event is named after the Stomp Out Suicide 5K event, which also honors Alissa and benefits Canvas Health.

In its first year, the tournament raised over \$6,000 and has subsequently raised well over \$6,000 each year. Alexa donates all of the proceeds to Canvas Health to support mental health and substance use care. In 2023, the tournament will move to a larger venue to accommodate the growing number of teams who want to be a part of the effort.

"I'm proud of creating a really fun event that people can rally around and support. I know Alissa would be proud of me," Alexa said.
